FIT RESERVATION POLICY – CABIN FARE ONLY

1. Reservation

- Name as per passport and date of birth is required.
- All passports must have 6 months' validity as at the end of the sailing period; Guests are solely responsible for obtaining and ensuring they have all necessary visas and travel documents prior to the cruise.
- Pregnant above 24 weeks & infants below 6 months at the time of sailing are not allowed to cruise; A passenger under 18 years of age must be accompanied in the same cabin by a passenger 18 years or older.
 - Infant (6-24 months): Infant prices subject to promotions and port charges. Gratuity fee will be waived for infants below 2 years old.
 - Adults traveling with a minor who is not their child or under their legal guardianship must provide the child's valid passport and visa (or a certified birth certificate) along with a notarized letter signed by at least one parent or legal guardian.

- Single occupancy at 200% of promotion rate of 1st pax cabin fare.
- Cabins allocated on random basis, not allowed to request cabin number/ cabin location/ adjoining room.

Note :

- Cooling period – grace period for consideration of bookings without cancellation charges levied.
- Cooling period policy is NOT applicable to the following situations:
 - Sailing during special holidays season; (Peak season)
 - The existing booking was cancelled previously and has been rebooked or postponed;
 - Bookings prior to promotions during travel fair.

2. Payment Schedule

- Deposit 50% of cabin fare, balance payment is 101 days prior to sailing.
- Peak Season 100% deposit of total fare.

3. Amendment Policy

Note :

- No amendment charges shall be levied for upgrading cabins in the same cruises, difference between original and prevailing rate will be charged.
- Add passengers in the same cabin the original booked value / promotional rates apply for the add on passengers.
- For any split-off and new cabins will be considered as new booking at prevailing rates.
- Total cabin change of passenger name will be regarded as cancellation.
- Any amendment request received less than 7 days consider as 100% cancellation.

4. Cancellation Policy

* On top of cancellation charges being charged by cruise line, guests are liable for an administration charge of RM50 per person for any cancellation made.

Note :

- 100% of full cabin fare will be levied as cancellation charges in case of during PEAK seasons such as Christmas, New Year and Chinese New Year.
- Change of cruise departure dates, change of vessel and down sale of cruise (such as reduction of cruise length) will be regarded as cancellation
